RULES

- This form must be filled out completely.
- Fax copies will not be accepted.
- Rebate requests must be submitted within thirty (30) days following tech date.
- A copy of BMWCCA log book must accompany this form (see below for details).
- All rebate requests must include current color photos of the vehicle showing the proper placement of the required supplier decals.
- Please allow 4 weeks for processing.

*** Decal requirements:**

1. All decals as required for all BMW Club Racecars, as specified on the club racing website. These decals must be easily visible from the side of the car.
2. Two (2) 12" H&R decals; placed prominently on each side of the car, between the wheel wells. Decals must be easily visible from the side of the car.

Rebate will come in the form of:

- A) If the person or business claiming the rebate is the same as shown as *Bill To* on the original Tire Rack invoice, the rebate will be in the form of a rebate credit, back in the form of payment used for the original purchase.
- B) If the person claiming the rebate is not the same as shown as *Bill To* on the original Tire Rack invoice, the rebate will be in the form of a Tire Rack Gift Certificate, mailed to the person claiming the rebate.

2014 BMWCCA Spec E36 Suspension Rebate Procedure Overview

H&R SPEC E36 SUSPENSION

H&R BMW/RSS Spec E36 Coil-Over (Part # RSS-E36-SPEC)

Competitors or businesses can be eligible to receive a \$500 Rebate. Duplicate requests submitted by both competitor and race prep shop will be paid to whomever is the first one to submit a proper rebate request. H&R suspension must be purchased from Tire Rack to be eligible for rebate.

Rebate Procedure

- A.** If person or business requesting the rebate **is the same** as shown as *Bill To* on the original Tire Rack Invoice purchasing the suspension
1. Complete BMWCCA Spec E36 Suspension Rebate Request Form
 2. Once verified, a \$500 rebate credit will be applied as appropriate below:
 - a. Retail Customer
 - i. to the credit card originally used to purchase the suspension
 - b. Business Customer
 - i. to the credit card originally used to purchase the suspension, or
 - ii. to the open account balance if purchased on terms, or
 - iii. as a refund check if paid by COD
 3. Allow 4 weeks for processing.
- B.** If person requesting the rebate **is not the same** as shown as *Bill To* on the original Tire Rack invoice showing the purchase of the suspension (i.e. competitor paid a race shop to prep the car and purchase the suspension, etc.)
1. Complete BMWCCA Spec E36 Rebate Request Form. Competitor is required to submit a copy of the Tire Rack invoice showing the purchase of the Spec E36 suspension kit. Contact the person/business who made the original purchase for the Tire Rack invoice.
 2. Once verified, a \$500 Tire Rack Gift Certificate will be mailed to the competitor submitting the request. We cannot issue a credit to an account or personal credit card.
 3. Allow 4 weeks for processing.
